# **SUMMARY OF THE WEBINAR**

This round table aims at presenting the experience of the Art Entr'Elles collective (AEE), which has been using community art, a method of artistic co-creation for the purposes of social justice, for more than 10 years with women in the legal system as a tool for skills development for the pre-employability of women. In its latest artistic project, an installation titled Dénombrement, un regard sur l'incarcération au féminin (a look at female incarceration), the collective introduced ICÉA's Our Strong Skills (NCF) module to its training program in order to work with the participants for recognition of their generic skills. The work of the Art Entr'Elles collective advocates the acquisition and sharing of knowledge throughout life, nonhierarchical collaboration, the experience and capacity of people, thus aligning its approach with the philosophy of the Fribourg Declaration on Cultural Rights.
